On September 28, 2018, Lakes Region Water Company, Inc., filed a request for an additional 60-day extension to file its petition for a Step Adjustment in the above-mentioned docket relative to improvements made at its Dockham Shores system located in Gilford. According to the request, despite near completion of the Dockham Shores project, more time is required to accurately complete its filing to the Commission. Staff concurs with the request. The Office of the Consumer Advocate did not respond to Staff's request for response.

The Commission has determined that the request for additional time is reasonable and will not unduly delay the proceeding or adversely affect the rights of any party. Accordingly, the request has been granted. Lakes Region Water Company, Inc.'s petition for a step adjustment is due December 1, 2018.
