Please find enclosed for filing with the Commission the original and six copies of a Stipulation and Settlement Agreement (Settlement Agreement) executed by all of the parties in this proceeding, pursuant to N.H. Code Admin. Rules Puc 203.20.

The Settlement Agreement provides that Commission Staff shall revise its methodology for calculation of the annual rate applicable to the net energy metering excess credit payment option under Puc 903.02, beginning with the 2017 calculation, consistent with the parameters specified in Section II of the Settlement Agreement. The Settlement Agreement effectively resolves all issues regarding the motion filed by Clifton Below to initiate this proceeding.

Commission Staff, on behalf of the parties, respectfully requests that the Commission consider and approve the Settlement Agreement, without the need for an evidentiary hearing.
