Request to Withdraw Registration as a Natural Gas Aggregator

Dear Mr. Mininberg:

On April 2, 2020, Hospital Energy Services, LLC (Hospital Energy) filed a request with the Commission to withdraw its registration as a natural gas aggregator in New Hampshire. In its request, Hospital Energy noted that its business would now be operated under a new aggregator registration issued to its affiliate, Hospital Energy, LLC. The withdrawal request filing included a copy of the notice sent to customers dated April 2, 2020.

Commission Staff filed a memorandum on April 9, 2020, summarizing its review of Hospital Energy's request and its determination that a waiver of Puc 3003.08(b)(2) was required because the customer notice had not been sent at least 30 days prior to the request for withdrawal. Staff recommended that rule waiver be granted under Puc 201.05 and that, if the rule waiver is granted, then the request meets the requirements for approval of withdrawal of a natural gas aggregator registration, pursuant to Puc 3003.08 and should be approved.

A rule waiver of the Puc 3003.08(b)(2) customer notice timing requirement has been granted, and Hospital Energy's request to withdraw its natural gas aggregator registration is approved, effective as of April 9, 2020, pursuant to Puc 3003.08. Accordingly, Hospital Energy's registration is deemed to be terminated as of that date.
