ORDER OF NOTICE On August 31, 2016, Concord Steam Corpora-tion (Concord Steam), a public utility supplying steam service to residential, commercial, and institutional customers, filed its annual cost of energy (COE) rates for the period November 1, 2016 through May 31, 2017 with the New Homeshire Public Utilities Commission (Commission). The proposed CDE rate is \$23.73 per Mib (thousand pounds) which is 13% lower than last year's weighted average rate of \$27.21 per Mtb. The petition and subsequent docket filings, other than any information for which confidential treatment is requested or granted by the Commission, will be posted to Commission's website http://www.puc.nh.gov/Regulatory/Docketbk/ 2016/16-811.html.

This filing raises, inter alia, issues related to the following: the torecast of sales; wood and natural gas supply and transportation casts; estimated wood vard operating expenses; purchasing decisions related to current and past annual fuel supplies; the causes and treatment of over and under recoveries; prior period costs and revenues; matters examined pursuant to RSA 374:4, including Concord Steam's business, financial and contingency plans; and the reasonableness of the proposed COE rate pursuant to RSA 378:7. Each party has the right to have an attorney present at its own **EXPENSE**
