Request to Provide Replacement Corporate Guaranty

Dear Ms. Nicks:

On January 6, 2017, Exelon Generation Company, LLC (Exelon) filed a corporate parent guaranty on behalf of Consolidated Edison Solutions, Inc. (Consolidated Edison Solutions) in the amount of \$350,000 (new guaranty). On January 17, 2017, you filed a letter confirming that the new guaranty is intended to replace Consolidated Edison Solutions' corporate guaranty dated December 12, 2005, as subsequently amended (old guaranty). The new guaranty was executed by Exelon, which acquired the retail electricity marketing assets of Consolidated Edison Solutions on September 1, 2016.

The new guaranty has a term that expires on December 27, 2021 and names the Commission as the guaranteed party. Staff reviewed the new guaranty and believes its material terms and conditions to be acceptable, as confirmed in Staff's memorandum dated January 17, 2017.

Please be advised that the Commission has approved the request to replace the old guaranty with the new guaranty. Accordingly, the Commission accepts the new guaranty as replacement for the old guaranty to serve as financial security for Consolidated Edison Solutions.
