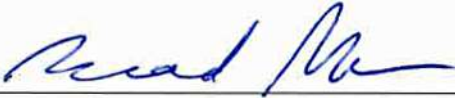
**CLEARVIEW ELECTRIC INC.'S PETITION TO INTERVENE**
