Request to Provide Replacement Corporate Guaranty

Dear Ms. Klaviter:

On October 30, 2017, Shraven Chopra, Treasurer of Exelon Generation Company, LLC (Exelon Generation), filed on behalf of Constellation Energy Services, Inc. (Constellation Energy), a corporate guaranty dated October 27, 2017 in the amount of \$500,000 (new guaranty), to replace the corporate guaranty dated December 20, 2016 in the amount of \$350,000 and filed with the Commission on December 22, 2016 (existing guaranty). Like the existing guaranty, the new guaranty was executed by Exelon Generation. The new guaranty is proposed to replace the existing guaranty.

The new guaranty is in the amount of \$500,000 and names the Commission as the guaranteed party. Staff reviewed the new guaranty and believes that the increase in the amount is favorable, and that the material terms and conditions are substantially the same as those of the existing guaranty, as confirmed in Staff's memorandum dated November 6, 2017 recommending Commission acceptance of the new guaranty.

Please be advised that the Commission has approved your request to replace the existing guaranty with the new guaranty. Accordingly, the Commission accepts the new guaranty as replacement for the existing guaranty to serve as financial security for Constellation Energy.
