



This filing does not change the corporate entity actually providing service, any of the terms and conditions, or any of the service offerings of UI Long Distance, Inc.


Also enclosed is an updated contact and trade name information NHPUC Form T-1 for UI Long Distance d/b/a Consolidated Communications Long Distance/UI.
