On January 11, 2018, Northern New England Telephone Operations LLC ("NNETO") filed a request for a letter of authorization from the Commission changing its certificated name from Northern New England Telephone Operations LLC d/b/a FairPoint Communications – NNE to Northern New England Telephone Operations LLC d/b/a Consolidated Communications - NNE, with an effective date of February 19, 2018. NNETO also filed revised tariff title sheets for NH PUC No.2, NH PUC No. 3 and NH PUC No. 4 to reflect the new company trade name and indicated it will submit a copy of the Certificate of Registered Trade Name issued by the Secretary of State when available.

On January 25, 2018, the Commission acknowledged NNETO's trade name change and allowed the proposed tariff changes to take effect on February 19, 2018.
