Deficiency Letter - Request for Additional Information

Executive Director Howland,

Clearview Electric, Inc. d/b/a Clearview Energy ("Clearview") received a Deficiency Letter on January 24, 2017, regarding the application for renewal of its registration that was submitted to the Commission on January 20, 2017.

In the Deficiency Letter, Mr. Goyette asked that Clearview provide:

- Evidence that the trade name "Clearview Energy" is registered with the New Hampshire Secretary of State; and
- Proof of financial security

In response to this request, Clearview hereby encloses its Application for Registration of Trade Name for the use of Clearview Energy, as filed 10/11/2013.

Additionally, Clearview has enclosed a Continuation Certificate for Bond No. SUR60000562, which states the bond as previously submitted is in full force and effect until the 21st day of March, 2018.

Lastly, pursuant to Puc 201.05, Clearview would like to request a waiver of the requirement that financial security instruments submitted with renewal registrations term be for 5 years and 90 days. Clearview proposes that the Commission renew the registration for the full 5 year term, and that Clearview will submit a Continuation Certificate for its bond no less than 45 days prior to the bond's annual expiration.


