Dear Ms. Howland:

This letter is to memorialize the agreement to a procedural schedule reached among Staff and Pennichuck Water Works, Inc. (PWW). On January 31, 2017, PWW filed its Petition for approval of its 2017 WICA surcharge based on the completion of its 2016 WICA projects; approval of its 2017 WICA projects for recovery under the WICA mechanism in 2018; and, approval, on a preliminary basis, of its proposed 2018 projects. A copy was also provided to the Office of the Consumer Advocate (OCA). The OCA filed a letter of participation on February 6, 2017.

Commission Staff and PWW agreed to the below-listed procedural schedule for review of this filing. The OCA did not respond to Staff's proposal.
