On February 23, 2017, Pennichuck Water Works, Inc. (PWW) submitted a petition seeking authority to update two internal references and clarify one reference within its tariff. These changes enhance the current tariff and do not involve any change to rates pursuant to RSA 378; Rates and Charges.

PWW seeks to make the following changes to their tariff:

1. Original Page 1 will be updated by adding the following to its Contents and Index: "Conference to Mediate Complaints Other Than Disconnection Complaints" with a reference to page 24.
2. Original Page 31, Section 20.A.1. will be updated to read, "Where the applicant fails to make any deposit or to execute any agreement as is required by the provision of Section 1, 3, and 35 of this Tariff."
3. Original Page 40, B.1. will be updated to reflect the correct reference to Section 35.

Staff supports the petition by PWW to update and clarify its current tariff with the changes discussed above.
