On May 14, 2018, Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty Utilities (Liberty) filed a partially assented-to motion to extend the deadline for filing its compliance tariff due May 14, 2018. Liberty stated that more time is needed to address the new rate schedules and language to comply with the May 1, 2018 Commission order. Staff counsel assented to the motion. The Office of Consumer Advocate was unavailable at the time of the filing.

The Commission has reviewed Liberty's motion and has extended the deadline for filing its compliance tariff to May 18, 2018.
