Re: DT 17-079, Dunbarton Telephone Company: Intrastate Access Tariff Revisions

Dear Mr. Nelson:

On May 12, 2017, Dunbarton Telephone Company (Dunbarton) submitted a filing to revise its intrastate access tariff for effect on July 1, 2017, pursuant to the Federal Communications Commission (FCC) Report and Order FCC 11-161 (Transformation Order). Consistent with the Transformation Order as revised, the tariff filing proposes to set Dunbarton intrastate access rates equal to current Dunbarton interstate rates.

Staff reviewed the proposed tariff changes for compliance with FCC orders and rules, and following its investigation, recommended that these proposed changes be allowed to go into effect.

Pursuant to New Hampshire 378:6, IV, this tariff revision "became effective" by operation of law on or about June 12, 2017, although the tariff revision specifies an effective date of July 1, 2017 and its rates will not apply until that time.
