In compliance with PUC 2003.01(j), the purpose of this letter is to inform the New Hampshire Public Utilities Commission that FairPoint Energy, LLC has changed its name to Energy Rewards, LLC. The entity name change has been filed with Nevada and New Hampshire, as Energy Rewards is a Nevada domestic limited liability company with foreign business status in New Hampshire.

As you may be aware, FairPoint Communications is now Consolidated Communications, which necessitated FairPoint Energy's name change. Consolidated Communications will continue to market Energy Rewards's products, similar to how FairPoint Communications had marketed FairPoint Energy's products in the past.
