On November 13, 2017, Public Service Company of New Hampshire d/b/a Eversource Energy (Company) filed an updated petition, with updated supporting testimony and schedules, in Docket No. DE 17-096 (Petition for Findings of Fact and Issuance of Finance Order). This updated petition incorporates new information generated from the results of the Auction Process examined in Docket No. DE 17-124 (Sale of Generation Facilities), and the Company's modification of its approach to incorporate a potential range of Stranded Cost securitization figures.
