On December 7, 2017, the Retail Energy Supply Association (RESA) filed a letter in the above-captioned docket. By all appearances, the letter intends to modify or clarify RESA's closing statement, which it offered at the November 30, 2017 hearing. Staff requests that the Commission disregard the letter.

As an intervenor in this docket, RESA had the opportunity to fully participate in this proceeding, including the opportunity to present testimony and to prepare for hearing. If the Commission should allow RESA the opportunity to modify its closing statement, all parties to the proceeding should be allowed the same opportunity in the interest of due process. Staff believes, however, that the appropriate remedy is to give no weight to the contents of the letter in the Commission's deliberation of the matters at issue in this docket.
