Good Afternoon Ms. Howland:

On behalf of the City of Berlin, together with the Towns of New Hampton and Bristol (collectively "the Municipal Intervenors"), I am authorized to relay that there is no need for the Discovery Conference currently scheduled for 8 a.m. tomorrow, November 2nd. While the Auction Parties did not produce all documents on Friday, October 27th as anticipated (some arriving on Monday the 30th and more on the afternoon of Tuesday the 31st), the Municipal Intervenors believe that by and large adequate Responses have been tendered to the Municipal Intervenors' Joint Data Requests such that appropriate follow-up questions can be asked of the Auction Parties' witnesses at the second Tech Session scheduled for November 8th. Accordingly, the Municipal Intervenors respectfully request that tomorrow's Discovery Conference be canceled.

The Municipal Intervenors do ask that the Commission simply rule on the Rules Waivers tendered by the Auction Parties and the Municipal Intervenors.
