Modification to Procedural Schedule

To the Parties:

On January 18, 2018, Pennichuck East Utility, Inc. (Pennichuck) filed an assented to motion to amend the procedural schedule in the above captioned proceeding. In its request, Pennichuck states that more time is needed for the parties to form a settlement for temporary rates. According to the procedural schedule, the settlement agreement is due on January 25, 2018, with testimony due on February 1, 2018. The parties request that the filing of the settlement agreement be extended to February 8, 2018, and testimony be moved to February 15, 2018.

The Commission has determined that the modification to the schedule is in the public interest and does not unduly delay the proceeding. Accordingly, the settlement agreement is due February 8, 2018, testimony is due on February 15, 2018, and the hearing will follow on February 26, 2018, at 9:00 a.m.
