4. For any group of meters that have been flagged with accuracy rates of 87% or less, please provide an updated status of what steps have been taken by Northern or its meter testing program vendor, to determine the defect responsible.

Response: Annual tests did not flag any groups of meters as having accuracy rates of 87% or less.

5. Please provide a detailed analysis and explanation of what is causing higher occurrence of accuracy issues of rotary meters being used by Northern.

Response: Northern is performing an analysis to determine what is causing the rotary meters to have lower accuracy rates than other classes of meters. The lower results are not specific to a particular size, model, or year of manufacture. Northern has contacted the rotary meter manufacturer to inquire about a cause. The manufacture responded that they are not aware of any issues or defects.

Northern is scheduled to meet with the testing vendor and meter manufacturer subject matter expert in April of 2018 to review testing procedures and observe testing practices.

Northern will provide Staff with a report of findings when analysis is complete.

6. Please provide an explanation of how Unitil Service's other affiliated gas divisions seem to be insulated from accuracy problems for rotary meters.

Response: The other affiliated gas companies are not subject to the same reporting requirement, and do not employ the reporting mechanisms that are used in New Hampshire. Accordingly, this type of data is not readily available, and there has been no determination that the other affiliated gas divisions are insulated from this issue.

7. Please provide when the accuracy of rotary meters first became an issue.

Response: Data indicates that rotary meter test results started to appear lower in 2014 when U&I became the Company's testing vendor.

8. Please describe what steps Northern and its vendor have taken to resolve accuracy problems with rotary meters.

Response: Northern reached out to the manufacturer, Dresser Meter, and U&I to review testing procedures. An on-site meeting is scheduled with Dresser testing engineers and U&I in Pennsylvania in April 2018, to observe testing practice and to ensure that rotary meters are tested according to Dresser manufacturer guidelines.

The Company's metering personnel are also working with Gas Operations to ensure all rotary meters are properly removed from the field without adding debris to the inside of the meter as well as ensuring the proper procedure of removing oil from the rotary meter's index.

Attachment 2 Gas Meter Testing Facility Cost Analysis 2017

Cost Analysis

The 2017 cost for Northern to outsource the testing of the 1020 meters associated with its NH customers was \$31,850, or an average of \$31.23 per meter.

The total cost for the 2017 testing of 2833 meters associated with Unitil Service's three affiliated gas companies was \$61,662, or an average of \$21.77 per meter.

It is estimated that in order to bring the meter testing and servicing operation in-house, Unitil Service would need to hire two full-time employees at the following annual cost (with benefits):

2 Full Time Employees w/ Benefits	\$176,405
Utility Expenses	\$3,500
Tool Replacements	\$1,000
Total	\$180,905

The estimated annual cost of \$180,905 for two employees, utilities, and tools would result in the cost per meter test for the 2833 meters tested in 2017 to be \$63.85 per meter.

Additional consideration would be required for the start-up costs that would be incurred to enable a meter testing facility are as follows:

Conclusion

Due to the estimated annual operating costs of \$180,905 exceeding the most recent annual expenditures of \$61,662 paid to vendors for performing testing, it is not economical at this time for Unitil to pursue establishing a gas meter testing facility.
