To the Parties:

On April 17, 2020, Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty Utilities (Liberty) filed a further status report pursuant to the secretarial letter dated February 25, 2020. The February 25, 2020 secretarial letter also required Liberty to file, if appropriate, a proposed revised procedural schedule assented to by all parties by April 17, 2020.

In its letter, Liberty stated that its work on the issues related to this docket and Docket No. DG 17-198 had reached the stage in which it could begin to develop a revised procedural schedule. Liberty requested that the Commission set May 15, 2020 as the deadline for Liberty to file a proposed revised procedural schedule assented to by the parties.

The Commission has granted Liberty's request. Liberty shall therefore file with the Commission, on or before Friday, May 15, 2020, a proposed revised procedural schedule to which all parties have agreed.
