Rescheduling April 10, 2020 Hearing

To the Parties:

The Commission scheduled a hearing on Omni Mount Washington Hotel, LLC's motion regarding contested rate case expenses and Abenaki Water Company, Inc's motion to extend the Step II filing deadline by secretarial letter dated February 4, 2020. This hearing had been scheduled to be heard remotely on April 10, 2020, but was postponed for logistical reasons by secretarial letter dated April 10, 2020. As required by the April 10 secretarial letter, Commission Staff filed a letter on April 14, 2020 notifying the Commission that all parties are available for the rescheduled hearing on April 23, 2020, at 10:00 a.m.
