Postponement of June 3, 2020 Hearing

To the Parties:

On May 29, 2020, the Office of the Consumer Advocate (OCA) filed a letter requesting the Commission to postpone the June 3, 2020 hearing on Abenaki Water Company, Inc.'s (Abenaki) motion to extend the Step II filing deadline. The OCA stated that Abenaki, Omni Mount Washington Hotel, LLC, Bretton Woods Property Owners Association, and Commission Staff (Staff) assented to this request.

The June 3 hearing was previously postponed from May 21, at the OCA's request, to permit the parties to continue settlement negotiations, which could resolve the issues in the above-captioned docket, as well as the issues in Docket No. DW 19-131. Due to concurrently scheduled matters, the OCA, in its May 29 letter, requested postponement of the June 3 hearing. June 3 is also the deadline for filing memoranda of law in Docket No. DW 19-131.

Accordingly, the Commission has postponed the June 3 hearing. *See* N.H. Admin. R., Puc 203.13. Staff shall discuss a new hearing date with the parties and file a status report/request for a new hearing date on or before Monday, June 15, 2020.
