On February 2, 2019, the Commission suspended the approved procedural schedule in the above-captioned docket until Liberty Utilities (Liberty) “makes its supplemental filing and a new, agreed upon schedule is proposed by the parties.” Liberty made its supplemental filing on March 15, 2019, with revisions filed on March 18, 2019. On April 3, 2019, the Commission issued a supplemental order of notice directing the parties in the docket to hold a Technical Session on April 25, 2019, to review the amended filing. At the technical session held on that date, the parties agreed to the following proposed schedule for the resumed docket proceeding:


