To the Parties:

On May 4, 2018, Staff submitted a request to reschedule the hearing in the above-referenced proceeding. According to Staff, Liberty's filing lacked sufficient information regarding its rate adjustment.

The Commission has determined that in order to fully consider Liberty's requested rate offset for tax rate reductions, the Company must provide additional information concerning the method of calculating the tax savings as well as the specific customer rate impacts of the adjustment. This letter shall serve as notice of a deficient filing pursuant to N.H. Code of Admin. R. Puc 1605.02(b). Liberty is directed to make an updated filing no later than May 10, 2018. Accordingly, the hearing scheduled for May 9, 2018, has been rescheduled to May 17, 2018, at 2:30 p.m.
