#### 1. DEFINITIONS

#### 2. SERVICES

##### 2.1 General

Network Services consist of any of the services offered hereunder, either individually or in combination. Each service is offered independently of all others.

##### 2.2 Transmission Service

2.2.1 Transmission Service is offered via the Company's facilities for the transmission of one-way and two-way communications.

2.2.2 Digital channels over the Company's Network are furnished for full-duplex transmission of digital signals at operating speeds as follows:

Voice Grade  
56 Kbps (DDS)  
1.544 Mbps (DS-1)  
44.736 Mbps (DS-3)

#### 3. RATES

##### 3.1 Special Construction

##### 3.1.1 Basis for Rates and Charges

Rates and charges for special construction will be determined by the Company on an individual basis and based, in part, on the costs incurred by the Company.

##### 3.2 Transmission Service

##### 3.2.1 General

Rates are composed of three elements which may apply to a Customer's service, depending upon the specific service requested and its location.

3.2.1.1 The channel termination rate element provides for the termination of the communications path at the Customer designated location. One channel termination charge applies for each Customer designated location at which a channel is terminated.

3.2.1.2 The channel mileage rate element is determined by the Vertical, and Horizontal Coordinates ("V&H") method, as set for on the National Exchange Carrier Association Tariff, F.C.C No. 4. When the calculation results in a fraction of a mile, the total is rounded up to the next whole mile before applying the rate.

3.2.1.3 Optional Features for which charges are applied only include multiplexing

#### 4. SWITCHED ACCESS SERVICE

##### 4.1 General

Switched Access Service, which is available to Customers for their use in furnishing their services to End Users, provides a two-point electrical communications path between a Customer's premises and an End User's premises. It provides for the use of common terminating, switching and trunking facilities, and for the use of common subscriber plant of the Company. Switched Access Service provides for the ability to originate calls from an End User's premises to a Customer's premises in the LATA where it is provided.

##### 4.2 Data Base 800 Service

Data Base 800 Service, which is available to all Customers, is an originating offering which provides a carrier identification function for numbers using the 800 NPA (i.e., 800-NXX-XXXX). The carrier identification function is performed using queries which are routed using the Company's CCS/SS7 network to the Company's Service Control Point (SCP). Data Base 800 Service may be provided with Call-Routing Capability, Carrier-ID-Only and/or Number Administration Service options.

##### 4.3 900 Access Service

900 Access Service is an originating offering utilizing trunk side Switched Access Service. The service provides a Customer identification function based on the dialed 900 number.

##### 4.4 Chargeable Optional Features: Features are located in Section E.4.6.5.

##### 4.5 Rate Categories

A. Direct Connect: The Company will provide Direct Connect between the Customer's premises and the Company's Local Switching Center switch(es). The transmission path is dedicated to the use of a single Customer. This Direct Connect rate is comprised of a per minute of use charge.

B. Tandem Connect: Tandem Connect consists of circuits from the Customer's tandem provider to the Company's Local Switching Center. This Tandem Connect rate is comprised of a Per Minutes of Use (MOU) charge.
