Small Diameter Private Fire Protection Non-Metered Service
Extension of Tariff Suspension

To the Parties:

On May 31, 2018, in Order No. 26,137, the Commission suspended Pennichuck Water Works, Inc.'s proposed tariff pages through August 30. On August 14, Commission Staff recommended that the Commission suspend the approved tariff suspension period by an additional two months, until October 31. The purpose of Staff's request was to allow the parties more time to conduct discovery and to attempt resolution of all issues in the docket.

The Commission has reviewed Staff's recommendation and the proposed tariff. The Commission has determined that suspension of the proposed tariff pursuant to RSA 378:6, I(b) for an additional period of 2 months, or until October 31, 2018, is warranted. Further suspension will facilitate additional investigation of the proposed tariff's provisions by Staff. This secretarial letter will serve as the Commission's suspension order.

Commissioner Giaimo took no part in the Commission's decision.
