## PENNICHUCK WATER WORKS, INC.

Petition for Approval of Changes to Rates and Terms for Fire Protection Services

Summary of Order *Nisi* No. 26,200 Approving Tariff Changes

On December 17, 2018, the Commission approved changes to the non-metered private fire protection rates and terms for customers of Pennichuck Water Works, Inc. (PWW). The Commission approved a specific configuration for the installation of private fire protection services, and grandfathered rates for certain non-conforming services installed and in service by December 31, 2018. The Commission also required customer credits for a number of residential customers who had paid for private fire protection at rates that were not appropriate for the service provided.

The Commission delayed the effectiveness of its approval to ensure that all interested parties receive notice of its determination and have an opportunity to request a hearing. All persons interested in responding to this order may submit their comments or file a written request for a hearing, which states the reason and basis for a hearing, no later than January 8, 2019. Any person(s) responding to such comments and requests for hearing shall do so no later than January 14, 2019. Following consideration of any comments and requests for hearing received, the Commission may further extend the final effective date of its order. The Commission's order shall become final and effective on January 16, 2019, unless the Commission orders otherwise.
