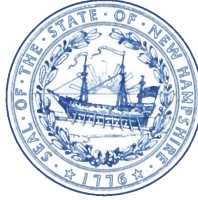

On September 5, 2018, the Commission held a duly noticed prehearing conference in the above-referenced matter. Appearances were entered by representatives of Liberty Utilities, Terry Clark and Commission Staff. Motions to intervene were taken under advisement.


Following the prehearing conference, parties and Staff met in a technical session. By letter dated September 7, 2018, Staff proposed the following procedural schedule and stated its belief that the schedule would afford all parties adequate time to review Liberty's petition and present any issues to the Commission for resolution:

First Set of Data Requests on Liberty's Petition	9/14/18
Responses to First Set of Data Requests	9/28/18
Second Set of Data Requests on Liberty Filing	10/18/18
Responses to Second Set of Data Requests	11/1/18
Technical Session	11/8/18
Hearing	11/20/18 at 10:00 am

Subsequently, Liberty Utilities and Terry Clark submitted letters indicating they do not oppose Staff's proposed schedule. Staff has represented that the Ashuelot River Local Advisory Committee stated in an email that it also does not oppose the proposed schedule.

The Commission has determined that the proposed schedule is in the public interest and therefore has approved it. For administrative efficiency, the Commission has elected to issue this secretarial letter as its initial prehearing order in this proceeding.
