Procedural Schedule

To the Parties:

On July 24, 2018, the Commission held a duly noticed prehearing conference in the above-referenced matter. Appearances were entered by representatives of Northern Utilities, Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty Utilities, the Town of Epping, the Office of the Consumer Advocate (participating as a full statutory party) and Commission Staff. At the prehearing conference, the Commission denied Liberty Utilities' motion to intervene and granted intervenor status to the Town of Epping.

Following the prehearing conference, parties and Staff met in a technical session after which Staff filed a letter dated September 7, 2018 informing the Commission that Staff would continue to work with the parties to determine an appropriate procedural schedule to govern the proceeding.


