Application to Renew Registration as Provider of Natural Gas Aggregation Service

Dear Ms. Hagger:

On August 2, 2018, SourceOne, Inc. (SourceOne) submitted an application with the Commission to renew its registration as a provider of natural gas aggregation service.

Commission Staff filed a memorandum on October 9, 2018, in which it confirmed its review of the application and its determination that the application meets the requirements of N.H. Code Admin. Rules Chapter Puc 3000. Staff noted that, pursuant to Puc 3003.05(d), SourceOne's renewal application was deemed approved 60 days after its receipt. Staff recommended that the Commission notify SourceOne that its application is deemed approved for a five-year term, beginning on October 12, 2018.

The Commission has approved Staff's recommendation. Accordingly, please be advised that SourceOne's application for registration is deemed approved, effective as of October 12, 2018. The registration is for a term of five years and expires at the close of business on October 12, 2023. Pursuant to Puc 3003.05(a), you must submit a renewal application at least 60 days prior to the expiration of the approved registration term, on or before August 13, 2023.

Please be aware that registered providers of natural gas aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at: http://www.puc.nh.gov/Regulatory/Rules/PUC3000.pdf.

Please note that, effective as of July 1, 2014, each registered natural gas aggregator is subject to an annual assessment of \$2,000, unless it demonstrates that its gross revenue in New Hampshire during the preceding fiscal year (from July 1 through June 30) was less than \$10,000, pursuant to RSA 363-A:2, III and 5.
