Dear Mr. Meehan:

On August 21, 2018, Northern New England Telephone Operations LLC d/b/a Consolidated Communications-NNE ("CCP") filed a request for approval of the Interconnection Agreement between CCI and Wide Voice LLC, under Section 252(i) of the Telecommunications Act of 1996. The companies are adopting the terms of the Interconnection Agreement between Neutral Tandem – New Hampshire, LLC (Neutral Tandem), and CCI (formerly Verizon New England, Inc.), approved by the Commission in Docket No. DT 07-091, along with Amendment #1 to that agreement, approved on October 24, 2017 in Docket No. DT 17-162.

Commission Staff filed a memorandum on August 24, 2018, recommending that the adoption of the interconnection agreement be allowed to go into effect by operation of law, 90 days after the date of the original filing.

The Commission has reviewed and approved Staff's recommendation. Accordingly, the adoption of the interconnection agreement shall be effective November 19, 2018.
