Approval of Petition Amendments

To the Parties:

On September 7, 2018, Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty Utilities (Liberty) submitted a petition to the Commission seeking approval of a renewable natural gas (RNG) supply and transportation agreement with RUDARPA, Inc. The petition filing included supporting testimony and exhibits, including joint testimony of William J. Clark and Mark E. Saltsman and a copy of an "RNG SUPPLY AND TRANSPORTATION AGREEMENT" between Liberty and RUDARPA, Inc. marked as Attachment WJC/MES-1 (RNG Agreement).

On March 5, 2019, Liberty filed revised versions of the Clark/Saltsman testimony and the RNG Agreement to correct certain errors in the text of each document pertaining to industry standards applicable to RNG.

Based on its review of Liberty's letter and the amended documents, the Commission has determined that the amendments will allow the just resolution of the proceeding and will not cause undue delay. The amendments therefore are permitted pursuant to Puc 203.10.
