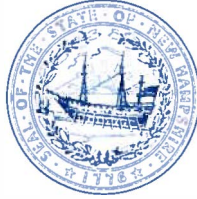

Enclosed please find the Public Utilities Commission's Conditional Approval Response, annotated to show the changes from the Final Proposal adopted on February 20, 2019. The revisions to Puc 3004.06(d) shown in the Conditional Approval Response are identical to those shown in the Conditional Approval Request submitted on behalf of the Commission on March 14, 2019. The Conditional Approval Response also includes certain editorial revisions recommended by Committee counsel.

The Conditional Approval Response is intended to address the conditions approved by the Joint Legislative Committee on Administrative Rules at its meeting on March 15, 2019, as described in Committee Attorney Michael Morrell's letter dated March 21, 2019. The Conditional Approval Response was approved by unanimous vote of the Commission at a public meeting held on March 27, 2019.

Upon receipt of written confirmation from your office that the Conditional Approval Response is in accordance with the conditional approval granted by the Committee, the Commission will proceed to readopt with the final amendments the Puc 3000 rules, with any additional formatting and editorial changes as may be identified by Committee counsel.
