New Hampshire Legal Assistance (NHLA) received the Notice of Docketing and Mandatory E-Filing issued in the above referenced case on October 29, 2021. In Eversource Energy's Notice of Appeal, The Way Home is listed as a party and NHLA is listed as its counsel.

I write to clarify that NHLA filed the enclosed Notice of Withdrawal with the New Hampshire Public Utilities Commission in Docket No. DE 19-057 on June 25, 2021. The Notice of Withdrawal states that The Way Home merged with Easter Seals New Hampshire, Inc. on July 1, 2021, and therefore, The Way Home no longer exists. NHLA was not able to represent Easter Seals in the proceeding so effective 12:01 A.M. on July 1, 2021, NHLA withdrew its representation of The Way Home. NHLA notified both The Way Home and Easter Seals of its withdrawal.
