Request for Change in Rates Proposed Procedural Schedule

Pursuant to the Order No. 26,279, issued on July 31, 2019, in the above-mentioned docket, a technical session was held on October 3, 2019, following a Prehearing Conference. Four participants attended; Pennichuck Water Works, Inc.
