To the Parties:

On September 20, 2019, the Commission held a duly noticed prehearing conference in the above-referenced matter. Appearances were entered by Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource), the Office of the Consumer Advocate (OCA), Clean Energy New Hampshire (CENH), and Commission Staff (Staff). The Commission granted the petition to intervene filed by CENH and took the petition to intervene filed by Sunrun Inc. under advisement.

Following the prehearing conference, Eversource, the OCA, CENH, and Staff met in a technical session and agreed upon the following schedule, which Staff submitted to the Commission by letter dated September 27, 2019:

Rolling Discovery on Eversource (Responses due within 10 business days)	September 23 – October 28, 2019
Eversource’s Final Responses to Round 1 Data Requests	November 12, 2019
Technical Session ¹	November 19, 2019, at 9:00 a.m.

The Commission has determined that the proposed schedule is in the public interest and, therefore, has approved it. For administrative efficiency, the Commission has elected to issue this secretarial letter as its prehearing order.
