When the Commission issued its Order Nisi in DW 19-135, we did not catch the requirement to post the order on the web site within 24 hours. Unfortunately, because of work on other matters, this was overlooked when the order came out. The Company did not become aware of it until today when the Company was putting together its affidavit of publication.

The Company has posted the Order to the Company web site. See attached. However, the Company will need to file a motion to extend the date for both publication on its web site. This is important because, without an extension, I may be unable to advise CoBank that the Company met all of the requirements with the PUC to close the financing. The bank could waive the requirement, but my suggestion is that the Company ask to extend both the publication date and the customer response date. We can do that tomorrow but I would like to touch base with you before we do so.
