Joinder Agreement to Affiliate Services Agreement Algonquin Power & Utilities Corp.

This Joinder Agreement to the June 30, 2017, Affiliate Services Agreement (the "Affiliate Services Agreement") is entered into and effective as of the 1st day of October, 2019, by and between Algonquin Power & Utilities Corp.
