

**Joinder Agreement to Affiliate Services Agreement**  
**Liberty Utilities (Park Water) Corp./Liberty Entities**

This Joinder Agreement to the January 23, 2017, Affiliate Services Agreement (the "Affiliate Services Agreement"), as amended, is entered into and effective as of the first day of October 2019, by and between Liberty Utilities (Park Water) Corp., a California corporation, ("Liberty Park Water") and Liberty Utilities (Gas New Brunswick) LP ("GNB"), Liberty Utilities (EnergyNorth Natural Gas) Corp., Liberty Utilities (Granite State Electric) Corp., Liberty Utilities (New England Natural Gas Company) Corp., Liberty Utilities (Peach State Natural Gas) Corp., Liberty Utilities (Missouri Water) LLC, (each individually a "Liberty Utilities Entity" and collectively, the "Liberty Utilities Entities"). The parties to this Agreement are otherwise collectively referred to as the "Parties" or individually referred to as a "Party."

WHEREAS, Liberty Park Water and each of the Liberty Entities are regulated utilities that are subsidiaries within the Liberty Utilities Co. family of companies;

WHEREAS, Liberty Park Water may perform information technology services for the Liberty Entities ("Services") and may incur certain expenses related to such Services;

WHEREAS, GNB desire to obtain the benefits of the Affiliate Services Agreement; and


