On behalf of Vermont Transco LLC (“VT Transco”), this letter is submitted in connection with the Order *Nisi* Granting License issued by the New Hampshire Public Utilities Commission (the “Commission”) on February 9, 2021. In that Order *Nisi*, the Commission ordered in part:






