Revised Procedural Schedule

To the Parties:

On July 21, 2020, Commission Staff (Staff) filed a request to amend the procedural schedule approved by secretarial letter dated May 27, 2020. Staff stated that amending the current procedural schedule was necessary, because it had agreed to Unitil Energy Systems, Inc.'s (Unitil) request for additional time to respond to Staff's third set of data requests, and the parties wished to have an opportunity to issue follow-up requests after reviewing Unitil's responses. The proposed revised procedural schedule also adds a technical session. Staff represented that the parties have agreed to the following revised procedural schedule:

Settlement Conference/Rebuttal Testimony	November 17, 2020, at 10:00 a.m.
Hearing	December 2, 2020, at 10:00 a.m.
