To the Parties:

On February 14, 2020, the Commission held a duly noticed prehearing conference in the above-referenced matter. Appearances were entered by Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource), the Office of the Consumer Advocate (OCA), and Commission Staff (Staff). No petitions to intervene were filed.

Following the prehearing conference, Eversource, the OCA, and Staff met in a technical session and agreed upon a schedule, which Staff submitted to the Commission by letter dated February 14, 2020. On May 5, 2020, Staff filed a letter with the Commission stating that the parties had agreed to the following amended procedural schedule:
