Good morning, Clare:

Eversource does have a long history of trying to work with with Mr Garneau regarding tree trimming and clearing in this Transmission right of way. You are likely aware that NHPUC does not have jurisdiction over Transmission rights-of-way, however Eversource offers you the following:

The area to be cleared is part of Eversource's existing Transmission right-of-way for which Public Service of New Hampshire dba Eversource has easements dated 1951 and 1964. The easements give Eversource the legal rights to manage the vegetation within the rights-of-way as necessary for the safe and reliable operation of the transmission lines located there. The Commission has noted that it does not have the authority to determine the property rights under such easements; "Only a court of competent jurisdiction may determine individual property owners'

rights." Order No. 26,103 at 17 (February 12, 2018).

The vegetation work is part of Eversource's right-of-way maintenance program and is not being performed to accommodate new construction. There are three existing 115 kV lines in this right-of-way and vegetation has grown to the point that they present dangers to the safe and reliable operation of those lines.

There were past discussions between Mr Garneau and Eversource regarding the vegetation in question, including a proposal in which he would perform maintenance of the trees within the right-of-way, however that proposal was never concluded, and any maintenance has either been insufficient or not performed. We met with Mr. Garneau and his attorney this past summer; but that meeting was unproductive due to their refusal to cooperate.

The trees identified for removal are species which are incompatible with good utility practice in Transmission rights-of-way because these species grow too tall. In this case, many of the trees are already too tall, and now are, or will be, in violation of minimum vegetation control distances as specified by the North American Electric Reliability Corporation (NERC) in the next growing season, and they need to be removed. The vegetative growth is so severe that an outage is required to safely remove trees under one of the lines and special operating instructions will be enforced for another. The trees need to be removed as soon as possible to preserve safety and reliability.

The City of Franklin, through its City Manager and Police Chief, is aware of the need for Eversource to perform this work. They are understanding and will provide assistance as needed.
