

Just a quick follow up. I was able to run this one to ground quickly. I have spoken with Transmission Planning and Protection Engineering. They are all set with you removing the tap from the G33 to GMP's North Brattleboro Substation. GMP will still need to work with PTO and Operations to put in the proper notice for any outages which would be needed to complete your removal.
