NOW COMES Michelle Painter, upon oath, being duly sworn, and states as follows:

1. I am counsel for Sprint Communications Company L.P. ("Sprint"),<sup>1</sup> the petitioner in the above-captioned docket, which involves Sprint's request for a rate adjustment to Telecommunications Relay Service ("TRS") as well as the addition of TRS services for customers in New Hampshire.
2. On August 27, 2020, the New Hampshire Public Utilities Commission ("Commission") issued Order No. 26,398, an Order *Nisi* Approving Rate Adjustment (the "Order").
