Re: DT 20-083, 2020 Intrastate Access Filings by Registered Telephone Utilities
ILEC Intrastate Access Tariff Revisions Effective July 1, 2020

To New Hampshire ILECs:

On July 2, 2020, Commission Staff (Staff) filed a memorandum stating that, based upon Staff's review, the intrastate access tariff revisions filed by the New Hampshire incumbent local exchange carriers (ILECs) appeared to be consistent with the Federal Communications Commission's (FCC) orders and rules. The ILECs made these filings in response to the FCC's Report and Order and Further Notice of Proposed Rulemaking regarding the Universal Service Fund and Inter-Carrier Compensation, in WC Docket Nos. 10-90, et al., and FCC Release No. 11-161, issued on November 18, 2011.

Accordingly, the intrastate access tariff revisions timely filed by the following ILECs went into effect by operation of law on July 1, 2020, as ordered by the FCC: Bretton Woods Telephone Company, Inc.; Chichester Telephone Company; Kearsarge Telephone Company; Meriden Telephone Company; Hollis Telephone Company d/b/a TDS Telecom; Merrimack County Telephone Company; Union Telephone Company; and Wilton Telephone Company.

With respect to Dunbarton Telephone Company, Inc. (DTC) and Granite State Telephone, Inc. (GST), the Commission has waived N.H. Admin. R., Puc 1603.07(a)(1) and Puc 1604.05(d) pursuant to Puc 201.05, so that DTC's and GST's intrastate access tariff revisions also took effect on July 1, 2020.
