RESPONSE:

During the pandemic, Liberty Utilities has continued to perform outreach to past due customers to ensure they remain aware of their account's balance and status. This includes outbound IVR calls, past due notices, and manual outbound outreach performed by our Collection Specialists. There has been no threat of disconnection at any point during outreach to our residential customers. Commercial collection activity has resumed as of 9/15/2020. The goal of all outreach is to set customers up on payment plans and ensure they are aware of any potential assistance programs who could help them with their bill.

Special attention has been made when speaking with our customers surrounding the additional state housing assistance that is available through the end of this year. While focused on housing specifically, utility bills are included in any potential grants customers may receive.

Liberty Utilities' customer outreach for the month of August also includes:

- Additional outbound calls from Customer Service Representatives with goal of setting up payment plans and ensure they are aware of potential assistance available.
- Social Media posts on Facebook advising customers that they can call our contact center at any time to discuss payment plan options, assistance, etc. Posts include information for customers on any updates or savings tips.
- Limited reopening of Concord Walk-in Center for customer payment drop off, account discussions. Remainder of NH Walk-In Centers remain closed with signage and up front IVR messages indicating closure.
- Updates to COVID-19 Update page on website, alert on homepage directing customers to this page.
- Liberty Utilities has worked with the other NH utilities, NHLA, PUC and other assistance agencies to prepare for a planned Customer Webinar in early November, allowing

customers to attend a presentation of payment assistance options in real time and ask questions, engage with the NH utilities.

REQUEST:

Describe the Utility's review and evaluation of best practices and successful initiatives undertaken in other states.

RESPONSE:

Liberty Utilities has continued to work closely, both within and outside of the organization, to assess the evolving situation and ensure that we are providing as consistent as possible management of accounts across the country and across the state. Recurring check in meetings with the other 3 large NH utilities have occurred since March. Liberty has been attending meetings with larger groups specifically surrounding this docket, as well as recurring meetings with Liberty counterparts across the country. Liberty Utilities has also been participating in weekly NGA calls with other utility companies, and has been involved with multiple meetings specifically regarding this docket and the discussions surrounding resumption of collections processing here in New Hampshire.

Communication has remained paramount during the resumption of disconnections, beginning in October, to ensure that we remain aligned with the other NH utilities in our approach and ensure that all guidelines outlines in the agreement for resumption of collections are honored. Below are some of the things that we've worked on over the last several months.

Attachment 5.1: Remobilization Guideline – Important guidelines for employees to follow when returning back to work to help better protect them and their families.

Attachment 5.2: Facility Access Process – This is a guidance document to ensure that we stay under the allowable limit as dictated by the remobilization plan.

Attachment 5.3: Site Access Verification Form – This form was created for visitors and contractors who may need access to any of our locations. If they filled out the form and answered yes to any of the questions, they would be restricted from accessing the facility.

Attachment 5.4: PPE Request Form – Managers fill out the form and request the required PPE for their employees upon returning back to work.

REMOBILIZATION GUIDELINES


Although you are back in the office, there are some important guidelines we ask that you follow to help ensure the safety of all our employees and their families. If you have any question about these guidelines, please contact EHS or your manager. Following these guidelines both in the office and at home will help keep you, our greatest asset, happy and healthy!

Occupancy Limits

The number of people allowed in public areas at one time has been limited. Please follow posted limits in bathrooms, conference rooms and elevators.

Social Distancing

Leave at least 6 feet (2 meters) of space between you and others. This includes walking outside. Please do not loiter in cafes, hallways, etc.



No Visitors

Visitors are not allowed, except for vendors/contractors who have completed the Site Access Verification Form. Employees who are still working remotely but need to go into the office would be required to contact their manager, who will then reach out to the site lead to request access.

Catering

Catering is not allowed for groups. However, individual food delivery can continue, following building access and mask protocols. Vendors are not allowed to come into the building and you must wear masks when meeting them outside. If you are going to bring food into the office, do not bring enough to share with others. The food you bring should only be consumed by you.

Mask Requirements

All employees must wear a mask when entering or exiting the building and when walking around the building (to copier, cafes, restrooms, etc.). Mask can be removed at desks if social distancing can be maintained.



PPE/Cleaning Supplies

Each employee returning to office will be provided with PPE. Hand sanitizer and other cleaning supplies are also placed throughout the buildings. If you require additional PPE (wipes, masks, hand sanitizer, etc.), please reach out to your supervisor.

Hygiene

Wash your hands frequently, wipe down surfaces before and after touching them, such as refrigerator handles, coffee makers, etc., and wipe down your work space daily.

Temperature Taking Protocol

Prior to coming into work every day, employees must take their temperature and answer five questions. If you answer yes to any of the questions, contact supervisor **before** coming to work. If you are at work and notice any symptoms, contact supervisor immediately.



Contact Log

Remember to complete a log of other employees you come into contact with each day you are in the office and ensure your manager has access to information if needed. Contact your department manager for a log.

ATTACHMENT 5.2
FACILITY ACCESS PROCESS

East Region Facility Access Protocol

This process is designed to provide guidance for employees who may need to access one of our facilities, but who have not been identified as needing regular facility access during Phase 1 of our re-mobilization plan.

As we have put in place a remote working program during the pandemic, all departments are expected to support their team members so they can operate from their home. Employees who are not part of the Phase 1 Re-mobilization Plan, but who may need occasional access to the facilities, may be allowed into the building on an exception-basis as determined by their Department Lead, their location's Site Lead, and the Regional Re-mobilization Lead, Kevin Spottiswood. The goal of this process is to limit the number of employees who are in the office space on any given day, following the plan limits identified for each phase.

Process/Expectations

1. Leaders are expected to maintain contact with their team members and fully support working from home. Our goal is to keep everyone safe, as well as balance the needs of providing an essential service to our customers.
2. Employee: Contact your department lead to request facility access. Identify the time you will need to be at the facility.
3. Department Lead: When you receive a facility access request from an employee on your team who is not designated as part of the Phase 1 RTW plan, or on a day that they are not scheduled to be in the building, please contact your site lead to discuss the request.
4. Site Lead: When you receive a facility access request from a department lead, access may be allowed as long as the number of employees in the building doesn't exceed the Phase 1 guidance. Contact Regional Remobilization Lead before granting approval. A tracking document will be provided to help with this process. This document may also be used in the event of a possible exposure.

Once approval is granted, the following guidelines should be adhered to when entering the office:

- Refer to your location's self-certification protocols, including but not limited to, temperature taking, qualifying questions, possible exposure, etc.
- Workers at the office environment are required to maintain a minimum of one workstation distance from any other workers. This may require approval by another office owner if your office is not conducive of this requirement.
- Maintain a minimum of 6' separation from your co-workers.
- Employees accessing the building are required to complete the online L&D training module prior to accessing the building.
- Follow posted occupancy limits in elevators, meeting rooms, restrooms, and break rooms.
- Frequent hand washing is required to minimize risk to yourself and others.
- Minimize frequent movement and minimize your footprint when you are in the facility.
- Upon entering the building and when moving around (other than at your work space) a face covering (nose and mouth) is required. Face covering may be removed at your desk if you are able to maintain social distancing.

We appreciate your support and understanding as we all do our part to stay safe, while continuing to provide an essential service to our customers.

A recurring monthly meeting was held with the supply chain team on September 16, 2020 to verify and understand our current materials situation. Liberty has not experienced any significant supply chain disruptions in supporting the Utility operations in both our gas and electric business. We are aware of minor & select increases in materials lead time, but after review, current stocking at our locations is adequate based on historical demand and any upcoming planned or scheduled work.

In stock COVID related supplies are substantial and adequate, noting that the availability of items remains limited due to global demand. Disinfecting wet wipes (Clorox Wipes) continue to be scarce and are forecasted to be in short supply well into to 2021. Supply Chain is ordering in limited numbers when they are available to meet & sustain our pandemic plan. Our joint crisis team is discussing the future supply needs as they align with a phased approach to limited reintegration.

September report response: In addition to the July report response shown below, Liberty Utilities successfully placed a \$600 million 10-year senior unsecured notes issuance which closed on September 23, 2020.

July report response: Regarding the current situation, the Utility (meaning Liberty Utilities (Granite State Electric Company) Corp. and/or Liberty Utilities (Energy North Natural Gas Company) Corp.) and/or its parent company do have adequate access to capital in the form of bank credit facilities. On July 17, 2020, the Utility's ultimate parent, Algonquin Power & Utilities Corp. closed on its equity offering of additional common shares which raised total proceeds of CAD 983 million before fees and commissions (USD equivalent is approximately \$724 million). Neither the Utility nor its parent company have suffered any credit rating agency downgrade as a result of COVID-19.

Describe incremental costs associated with the COVID-19 pandemic since the State of Emergency order, how the cost is calculated, cost to date, accounting treatment, impact on earnings, and proposed or planned rate treatment.

RESPONSE:

The incremental costs are tracked by establishing work orders by departments to which all COVID-19 related expenses are charged. These work orders are mapped to the Miscellaneous General Expense Account (FERC 930.2). The use of work orders allows the Company to track these incremental costs by the categories described below:

- Labor consists of labor cost for field employees who cannot work from home, are not ill but have been exposed to the virus and have been asked to self-quarantine.
- Non-labor expenses principally relate to personal protective equipment, cleaning agents (sanitizers and towel wipes), and fees.
- Waived fees represent waived customer late fees. These fees, although they are not an expense, represent a cost of the pandemic because they represent revenue that the Company would ordinarily receive from fees that have been approved by the Commission. By not being allowed to charge those fees, the loss of revenue has the same impact to the Company's financials as the incurrence of an expense. Late fees are calculated within the billing system but not applied to customer accounts. The Company is tracking waived fees in Excel.

Accounting treatment, impact on earnings, and proposed or planned rate treatment.

Earnings impact (pre-tax) is equal to the amounts charged to expenses for the incremental COVID-19 costs and the amount of waived late fees that have not been recorded on the books. This impact amounts to \$916,612 for March through October 2020. The Company proposes that the Commission establish a regulatory asset in which these incremental costs can be deferred with future rate recovery of the costs to be determined at a later date. Taking into consideration things like quarterly and annual financial reporting, establishing a regulatory asset in the near future would allow for more clarity as to the financial impacts associated with the pandemic and would eliminate the effects of any inconsistent patterns in costs and revenue impacts that may be experienced as the pandemic continues over time.
