Dear Secretary Howland:

In its November 6, 2020 Order *Nisi* (Order No. 26,422) in the above-referenced docket, the Commission directed Unitil Energy Systems, Inc. (“Unitil” or the “Company”) to publish the Order on the Company’s website within one business day (i.e., Monday, November 9). As explained in the Company’s letter and affidavit dated November 13, 2020, the Order was not posted on the Company’s website until Thursday, November 12, two business days after the publication date established by the Commission.

The Commission subsequently issued a Secretarial Letter on November 25, 2020 establishing a modified timeline for publication, comments, and the effective date of the Order Nisi.
