STIPULATION OF DISMISSAL OF COMPLAINT BY TOWN OF DURHAM PUBLIC WORKS, CITY OF DOVER, CITY OF PORTSMOUTH, CITY OF SOMERSWORTH, TOWN OF NEWMARKET, TOWN OF NEWINGTON AND TOWN OF EXETER AGAINST CONSOLIDATED COMMUNICATIONS OF NORTHERN NEW ENGLAND COMPANY, LLC, D/B/A CONSOLIDATED COMMUNICATIONS-NNE

NOW COME the undersigned City of Dover, Town of Newington, Town of Newmarket, Town of Durham, City of Somersworth, Town of Exeter and City of Portsmouth (collectively “Municipalities”), together with Consolidated Communications of Northern New England Company, LLC, and, having resolved the issues raised by the Municipalities in the above-referenced docket by virtue of a settlement agreement between them, hereby stipulate to the dismissal, without prejudice, of the following:

- i. Complaint dated June 18, 2020 by Town of Durham, City of Dover, City of Portsmouth, City of Somersworth, Town of Newmarket, Town of Newington, and Town of Exeter (PUC Docket Entry #1);
- ii. City of Dover supplement dated July 31, 2020 (PUC Docket Entry #6);
- iii. City of Somersworth supplement dated August 18, 2020 (PUC Docket Entry #7);

WHEREFORE, the undersigned respectfully request that the Honorable Commission:

- A. Approve this stipulation and dismiss the above-referenced complaints, without prejudice; and
- B. Administratively terminate and close the above-referenced docket.






